GUIDANCE NOTES ON COMPLETING THIS FORM

Part 1

- (a) In this section you should include details of your job, or any business that you carry on. Please indicate which, by deleting those words in square brackets which do not apply.
- (b) If you are employed, or are a partner in a firm or a director of a company, give in this section the name of your employer, or the firm or company. Please indicate whichever applies by deleting the appropriate words in square brackets.
- (c) Complete this section by giving details of any payments you have received in respect of your election expenses (for example, from a political party or other group) or payments made to you in connection with carrying out your official duties. This does **not** include any allowance received by you from the Council of which you are a member.
- (d) If you are a shareholder of a company or similar body, which occupies premises in the Council's area, you should give details of such company or other body. This only applies if your holding is over a nominal value of £25,000 or over 1 per cent of the total share capital of a relevant company. If less than this, there is no need to complete this section.
- (e) If you are a partner in a firm or a paid director of a company, such as in (d) above, which supplies goods, services or works to the Council, you should give in this section particulars of any contract between the firm/company and the Council (continue on a separate sheet if there is not enough space).
